Disclosure

Me-Dian Credit Union is offering four bursaries of \$1,250 each, two bursaries of \$1,000 each, and one bursary of \$500. Students may apply to multiple categories; however, each student is eligible to receive **only one award per year**.

Successful applicants must sign and return a written declaration to Me-Dian Credit Union.

Eligibility Requirements

1. Applicant must be a current Manitoba resident.
2. The applicant must be accepted to attend or enrolled in a recognized University or College in Canada for the current/new academic school year *unless applying for the Academic Excellence stream*.

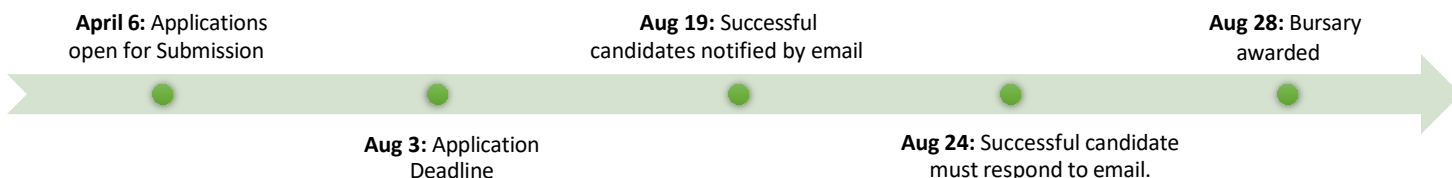
Evaluation Categories

Bursaries will be awarded to individuals who encompass a well-rounded character. We are pleased to offer five categories in which every individual may apply, which include the following:

1. **General Bursary:** Essay describing your career goals and why you chose this specific career. Minimum 250 words; Maximum 750 words. A reference letter from a teacher, employer, community group/organization of which the applicant was involved in, is required.
2. **Leadership Bursary:** Essay discussing your leadership roles throughout the year and future career goals. Minimum 250 words; Maximum 750 words. A reference letter from a teacher, employer, community group/organization of which the applicant had leadership involvement, is required.
3. **Community Involvement Bursary:** Essay detailing your extra-curricular activities or impact community involvement has had on you. Minimum 250 Words; Maximum 750. A reference letter from a teacher, employer, community group/organization of which the applicant had community involvement, is required.
4. **Business - Finance Degree:** Transcript or Acceptance Letter confirming student is enrolled in a degree program related to business and/or finance and an essay of explanation on why they chose the specific educational path. Minimum 250 words; Maximum 750 words. A character reference letter from a teacher, employer, community group/organization was involved in, is required.
5. **Academic Excellence Bursary:** Transcript showing grades maintained above 90% average or improvement of grades above 75% average over the course of the academic year. Must include letter of recommendation from a faculty member.

Application Process

1. All applicants must include the following:
 - A transcript of marks from the educational institution the applicant is currently attending.
 - If attending post-secondary in the year of application, copy of acceptance letter from post-secondary education institution or proof of enrolled courses is required.
 - Completed Me-Dian Credit Union Bursary Application.
2. Once the application is submitted you will receive a notification by email that it has been received.
3. Successful candidates will be notified **through the email address** provided by August 19th, 2026.
4. Successful candidates must respond to notification within 5 business days.
5. The bursary will be paid to the recipient by **Primary Order** as of August 28th, 2026, and it is not renewable.

Terms and Conditions – Post -Secondary Bursary Application

1. GENERAL

The Post-Secondary Bursary Award (the "Contest") begins April 6th, 2026, at 9AM and ends at 11:59PM on August 3rd, 2026 Central Standard Time (CST). The Post-Secondary Bursary Award is run by Me-Dian Credit Union (the "Sponsor"). For the purposes of the Award, the "Award Group" is composed of the Sponsor, or other legal entity directly involved in the Post-Secondary Bursary Program and their respective officers, directors, employees, agents, and other representatives. No purchase is necessary.

2. ELIGIBILITY

The Contest is open to all Manitoba students enrolled in post-secondary school in the fall (must be a recognized University or College in Canada for the current or upcoming academic year).

3. HOW TO ENTER

Eligible Entrants must complete the Me-Dian Credit Union Bursary Application Form and submit all required documentation mentioned in the said form. Entrants may submit a total of five (5) application forms; one per each category listed in the application form with proper documentation.

4. HOW TO QUALIFY

After the application deadline as mentioned on the Me-Dian Credit Union Bursary Application Form, on the date of award at 9:00 a.m. CST at 303 Selkirk Avenue Winnipeg, MB R2W 2L8, the Sponsor will select seven (7) Entry's received during the Post-Secondary Bursary Award Period as eligible to win a bursary ("Selected Entrant"). Odds of being selected as eligible to win a bursary depend on the total number of eligible entries received during the period.

5. BURSARY CLAIM CONDITIONS

The Selected Entrant will be notified via the email address provided on the Me-Dian Credit Union Bursary Application Form within approximately five (5) business days of the selection.

In order to be declared a winner, the Selected Entrant must:

- (i) respond to the notification of selection within five (5) business days of the first attempt by the Sponsor;
- (ii) sign and return to the Sponsor, within the stated time period, a written declaration and social media release form, releasing the Sponsor from any liability in connection with this Contest or the use, misuse, or possession of any bursary (the "Release"); and
- (iii) otherwise comply with these Official Terms and Conditions.

1Winners will be awarded their bursary in the form of a bank draft.

Return of any bursary or winner notification as undeliverable, inability to reach the Selected Entrant, failure of the Selected Entrant to respond to notification by the deadline, failure to provide proof of eligibility (if requested), the Release, or other required documentation in a timely manner, or other non-compliance with these Official Terms and Conditions may result in disqualification, forfeiture of the bursary, and, at the Sponsor's sole discretion, selection of an alternate Selected Entrant for the forfeited bursary in accordance with these Official Contest Rules, who will be subject to disqualification in the same manner.

6. BURSARIES

There are seven (7) annual bursaries available to be won consisting of four (4) \$1,250 and two (2) \$1000 and one (1) \$500 only where Me-Dian Credit Union will issue a bank draft to the winners for pick up in branch.

Bursary must be accepted as awarded and may not be substituted, transferred, or redeemed for cash at the time of said bursary awarded. Sponsor forfeits the right to substitute a bursary of greater or equivalent monetary value if a bursary cannot be awarded as described for any reason. Sponsor will not replace any lost or stolen bursaries. Any other taxes, costs or expenses associated with the bursaries not specified herein will be the responsibility of selected winners.

7. RIGHT TO VOID / TERMINATE / SUSPEND / MODIFY

Sponsor reserves the right to terminate, suspend or modify this Bursary Award, in whole or in part, at any time and without notice or obligation if, in Sponsor's sole discretion, any factor interferes with its proper conduct as contemplated by these Official Contest Rules. Without limiting the generality of the foregoing, if the Contest, or any part thereof, is not capable of running as planned for any reason, including but not limited to infection by computer virus, bugs, tampering, unauthorized intervention, fraud, programming errors, or technical failures, which, in the sole discretion of Sponsor, corrupt or affect the administration, security, fairness, integrity or proper conduct of this Contest, Sponsor may, in their sole discretion, void any suspect entries and: (a) terminate the Contest, or any portion thereof; (b) modify or suspend the Contest, or any portion thereof, to address the impairment and then resume the Contest, or relevant portion, in a manner that best conforms to the spirit of these Official Contest Rules; and/or (c) award the bursaries from among the eligible, non-suspect entries received up to the time of the impairment in accordance with the winner selection criteria discussed above.

Winning a bursary is contingent on fulfilling all the requirements set forth herein. Decisions of Sponsor and/or any independent contest judging organization will be final and binding on all matters pertaining to this bursary Award. Sponsor reserves the right to correct any typographical, printing, computer programming or operator errors. Sponsor's failure to enforce any term of these Official Terms and Conditions shall not constitute a waiver of that provision. The invalidity or unenforceability of any provision of these Terms and Conditions shall not affect the validity or enforceability of any other provision. If any provision of the Terms and Conditions is determined to be invalid or otherwise unenforceable, then the Official Terms and Conditions shall be construed in accordance with their terms as if the invalid or unenforceable provision was not contained therein. Sponsor reserves the right at its sole discretion to disqualify any entrant who tampers or attempts to tamper with the entry process, the operation of the bursary Award, violates the Official Terms and Conditions, or acts with intent to annoy, abuse, threaten or harass any other person. **WARNING:** Any attempt by an entrant or any other individual to deliberately damage any website associated with this bursary award or undermine the legitimate operation of the program is a violation of criminal and civil laws, and sponsor reserves the right to prosecute and seek damages to the fullest extent permitted by law.
